

AirSafe.com – TSA officer in alleged sexual assault while in uniform

On November 20, 2011, Harold Glenn Rodman, a 52-year-old TSA employee who lives in Manassas, Virginia, was arrested and later charged with several felonies, including three sexual assault related charges (aggravated sexual battery, object sexual penetration, and forcible sodomy) and one kidnapping related charge (abduction with intent to defile).

According to the Prince William County Police Department and several media reports, On November 20, 2011, at 3:25 am, police responded to a reported sexual assault of a 37-year-old woman from Manassas. The victim and a friend were in a vehicle when they were allegedly approached by an unknown man, later identified as Rodman. The victim was allegedly assaulted after she stepped out of the car to talk with the suspect. The man was allegedly wearing a TSA uniform and displayed a badge to the victim before sexually assaulting the victim. Rodman allegedly fled the scene on foot, but was later arrested while coming out of his residence.

Attached are a number of records from the Prince William County (Virginia) General District Court that detail the four charges against Rodman, as well as a document containing a summary of Rodman's arrest report from the Prince William County (Virginia) Police Department.

Harold Rodman's name did not come up in a search of either the Virginia State Police database of convicted sex offenders, or the US Department of Justice national database of sex offenders.

Sexual Assault – On November 20th at 3:25AM, police responded to investigate a sexual assault which was reported to have occurred in the 10500 block of Winfield Lp in Manassas (20109). The victim, a 37 year old woman of Manassas, reported to police that she and a friend where in the area above when they were approached by an unknown man, later identified as the accused. The man was wearing a uniform and displayed a badge to the victim. The accused then sexually assaulted the victim before fleeing on foot. Police responded quickly and during a canvass, the accused exited his residence matching the description provided by the victim. The accused was subsequently arrested in connection with the incident. The investigation revealed that the accused was an employee of the TSA and was wearing his uniform at the time of the incident.

Sexual Assault – On November 20th at 2:53AM, police responded to investigate a sexual assault which was reported to have occurred at the K2 Club located at 14633 Jefferson Davis Hwy in Woodbridge (22191). The victim, a 29 year old woman of Dumfries, reported to police that she was at the club and noticed the accused, a known acquaintance. Later that evening, the victim left the club and was walking to her vehicle parked in the parking lot. There, the accused was standing next to her vehicle. The accused pulled the victim closer and assaulted her. The victim was able to get away and contact police. The accused was located and arrested.

Abduction / Assault & Battery – On November 20th at 12:31AM, police responded to the MVP Bar and Grill located at 7518 Old Linton Hall Rd in Gainesville (20155) for an assault. The victim, a 25 year old woman of Bealton, reported to police that she was standing outside of the bar when a vehicle, operated by the accused, pulled up. The victim got into the vehicle where the accused assaulted the victim. The accused attempted to prevent the victim from getting out of the vehicle. The victim was able to contact police. The accused was still at the bar and was arrested without further incident.
